If you ask the Wordsworth Trust to collect a payment, confirmation of the amount and date will be given to you at the time of the request. • If an error is made in the payment of your Direct Debit by the Wordsworth Trust or your bank or building society, you are entitled to a full and immediate refund of the amount paid from your bank or building society. If you receive a refund that you are not entitled to, you must pay it back when the Wordsworth Trust asks you to. • You can cancel a Direct Debit at any time by simply contacting your bank or building society. Written confirmation may be required. Please also notify us.

6. Gift aid

Choosing to gift aid your donation increases its value by 25%, at no extra cost to you.
